



## APT COMPETITION TERMS & CONDITIONS

1. Information on how to enter and the prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of the terms and conditions.
2. Entry is open only to Australian residents only.
3. The Promoters are Travel Daily. The Prize Suppliers are Australian Pacific Touring Pty Ltd. (44 004 684 619) Employees of The Promoters and The Prize Suppliers and their advertising agencies, subagents, respective employees and their immediate families are ineligible to enter.

The prize will be awarded to the person with: the highest number of correct answers provided over the month of April and the best response to the last question (as judged by the Judging Panel).

### PRIZE TERMS & CONDITIONS

The prize consists of a 17 day 'Southeast Asia Adventure' expedition cruise with APT in a Standard Suite, including all accommodation, meals, activities and transfers on tour, as specified in the chosen trip brochure itinerary.

The value of this prize, itinerary and inclusions are correct at time of printing and subject to change at any time. Any change to the prize between the publishing date and the date the prize is claimed is not the responsibility of the promoter(s). The value of the prize is correct as at time of printing.

### Conditions

- Trip is subject to availability at time of reservation and reservations must be made at least 90 days prior to the departure date of the tour.
- The total prize value is up to \$27,590 (\$13,795 per person) (including GST). Prize value is recommended retail price, and is subject to change. The Promoter accepts no responsibility for any variation in the prize value.
- Winner and guest must travel together. Trip is provided on a twin share basis.
- If the winner is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian. Age restrictions apply. The decision for any person under 18 years of age to travel is at the absolute discretion of the management of APT. Any minor guest must be accompanied by parent/legal guardian on the trip.
- Prize is non-transferable, non-refundable, cannot be sold or exchanged for cash and cannot be used in conjunction with any other offer.

- Accommodation selection, location and room type and air carrier selection and flight routing is at the sole discretion of the Promoter and the Sponsors.
